PLAINTIFFS' COMPLAINT FOR DAMAGES

COME NOW, BETHELHEM GETU HUNDIE and GETAHUN BIRHANU, as surviving parents of MAYA GETAHUN, deceased; and BETHELHEM GETU HUNDIE, as the personal representative of THE ESTATE OF MAYA GETAHUN, as Plaintiffs, and file this complaint against PIEDMONT HEALTHCARE, INC.; PIEDMONT EASTSIDE HOSPITAL, INC.; EASTSIDE MEDICAL CENTER, LLC; RICHISA SALAZAR, MD; and JOHN/JANE DOES 1-10, showing this Honorable Court the following:

INTRODUCTION

This is a case about the wrongful death of 2-year-old Maya Getahun who died needlessly because of sub-standard medical care she received at Piedmont Eastside Medical Center in Snellville, Georgia. Maya's parents brought her to the emergency department after she was bitten by ants and developed an allergic reaction. While recognizing this was an allergic reaction, the medical staff waited over 20 minutes before administering epinephrine, causing Maya's condition to worsen. The ER physician, Dr. Richisa Salazar, attempted to intubate Maya, but once she started the procedure, Dr. Salazar realized the ER did not have the correctly sized equipment necessary for a young child. Maya's parents looked on helplessly as their daughter slowly died from lack of oxygen.



This action arises out of medical care negligently provided to two-year-old Maya Getahun on October 7, 2024, resulting in baby Maya's death.

2.

Plaintiffs assert claims of professional negligence against each Defendant, either directly or vicariously.

3.

Plaintiffs assert claims of ordinary negligence against each corporate Defendant, Piedmont Healthcare, Inc.; Piedmont Eastside Hospital, Inc.; and Eastside Medical Center, LLC.

4.

Plaintiffs demand a jury trial on all issues.

Parties, Jurisdiction, and Venue

5.

Plaintiffs Bethelhem Getu Hundie and Getahun Birhanu are citizens and residents of the State of Georgia. Plaintiffs submit to the jurisdiction of this Court and to venue in Gwinnett County.

6.

Defendant Piedmont Healthcare, Inc. ("Piedmont Healthcare") is a resident of Cobb County, Georgia. Pursuant to O.C.G.A. § 9-10-31, Piedmont Healthcare is

subject to venue in this Court, because at least one of its co-defendants is directly subject to venue here.

7.

Piedmont Healthcare may be served with process at the offices of its registered agent, CSC of Cobb County, 192 Anderson Street, N.E., Suite 125, Marietta, Cobb County, Georgia, 30060.

8.

Piedmont Healthcare has been properly served with this Complaint.

9.

At all times material to this action, Piedmont Healthcare was the parent corporation of Defendant Piedmont Eastside Hospital, Inc. Piedmont Healthcare thus managed the functions of Piedmont Eastside Hospital, Inc.

10.

Defendant Piedmont Eastside Hospital, Inc. ("Piedmont Eastside") is a resident of Cobb County, Georgia. Pursuant to O.C.G.A. § 14-2-510(b)(3), Piedmont Eastside is subject to the venue of this Court because (i) the cause of action arose in Gwinnett County, (ii) Piedmont Eastside maintains an office in Gwinnett County; and (iii) Piedmont Eastside transacts business in Gwinnett County.

11.

Defendant Piedmont Eastside may be served with process at the offices of its registered agent, CSC of Cobb County, 192 Anderson Street, S.E., Suite 125,

Marietta, Cobb County, Georgia, 30060.

12.

Piedmont Eastside has been properly served with this Complaint.

13.

At all times material to this action, Piedmont Eastside was the parent corporation of Defendant Eastside Medical Center, LLC, a disregarded entity.

Piedmont Eastside thus managed the functions of Eastside Medical Center, LLC.

14.

Defendant Eastside Medical Center, LLC ("EMC") is a resident of Cobb County, Georgia. Pursuant to O.C.G.A. § 14-2-510(b)(3), EMC is subject to the venue of this Court because (i) the cause of action arose in Gwinnett County, (ii) EMC maintains an office in Gwinnett County; and (iii) EMC transacts business in Gwinnett County.

15.

Defendant EMC may be served with Process at the offices of its registered agent, CSC of Cobb County, 192 Anderson Street, S.E., Suite 125, Marietta, Cobb County, Georgia, 30060.

16.

EMC has been properly served with this Complaint.

17.

At all times material to this action, Piedmont Healthcare, Piedmont Eastside,

and/or EMC was the employer or other principal of Defendant Richisa Salazar, MD, who was acting incident to, and within the course and scope of, her agency or employment.

18.

Defendant Richisa Salazar, MD is a resident of Cobb County, Georgia, and is subject to the jurisdiction and venue of this Court and may be served with process at her place of residence at 2178 Waldrop Rd, Marietta, GA 30066.

19.

At all times material to this action, Dr. Salazar was a physician licensed to practice medicine in the State of Georgia and held herself out to Ms. Hundie and Mr. Birhanu, and to members of the general public, as a physician skilled in the practice of emergency medicine.

20.

At all times material to this action, Dr. Salazar was an employee or other agent of Piedmont Healthcare, Piedmont Eastside, and/or EMC, and was acting incident to, and within the course and scope of, her agency or employment.

21.

Defendants John/Jane Does 1-10 are those yet-unidentified natural and legal persons whose negligent acts and/or omissions caused or contributed to the injuries and damages complained of here.

Jurisdiction is proper in state court.

23.

Venue is proper in Gwinnett County.

Facts

24.

Plaintiffs repeat, reallege, and re-aver each and every allegation contained in the paragraphs above as if fully set forth herein.

25.

On or about October 7, 2024, Ms. Hundie and Mr. Birhanu brought their minor child, Maya Getahun, to the emergency department of Piedmont Eastside Medical Center South Campus in Snellville, Georgia ("Hospital"). Maya had been bitten by fire ants.

26.

Dr. Salazar was assigned as Maya's attending physician.

27.

Roshayla Bracely, RN, triaged Maya. Maya had wheezing, labored breathing, and a rash. Ms. Bracely assigned Maya to Acuity Level 2.

28.

Maya was exhibiting signs and symptoms of an allergic reaction.

The allergic reaction was causing Maya respiratory distress.

30.

Maya required immediate medical attention, including the rapid administration of epinephrine to halt the allergic response.

31.

Providers at the Hospital allowed more than 20 minutes to pass before administering epinephrine to Maya.

32.

One dose of intramuscular epinephrine was administered to Maya.

33.

Though Maya had a blood oxygen saturation of 97%, Dr. Salazar decided to intubate Maya using rapid sequence intubation (RSI) drugs etomidate and succinylcholine.

34.

Dr. Salazar was not prepared to intubate Maya because Dr. Salazar did not confirm she had correctly sized pediatric intubation equipment available *before* she began the RSI attempt.

35.

As the RSI drugs paralyzed Maya, Dr. Salazar discovered that the Hospital lacked the equipment needed to complete the pediatric intubation.

Maya died under the care of Dr. Salazar, Ms. Bracely, and the other healthcare professionals at the Hospital.

37.

Maya was two years old at the time of her death.

Respondeat Superior Allegations

38.

Plaintiffs repeat, reallege, and re-aver each and every allegation contained in the paragraphs above as if fully set forth herein.

39.

At all times material to this action, Dr. Salazar was an employee or other actual or apparent agent of Piedmont Healthcare, Piedmont Eastside, and/or EMC, and was acting incident to, and within the course and scope of, her agency or employment.

40.

Defendants Piedmont Healthcare, Piedmont Eastside, and/or EMC are thus vicariously liable for the negligence of Dr. Salazar, pursuant to the doctrines of agency and respondent superior.

41.

At all times material to this action, Roshayla Bracely, RN, was an employee

or other actual or apparent agent of Piedmont Healthcare, Piedmont Eastside, and/or EMC, and was acting incident to, and within the course and scope of, her agency or employment.

42.

Defendants Piedmont Healthcare, Piedmont Eastside, and/or EMC are thus vicariously liable for the negligence of Ms. Bracely, pursuant to the doctrines of agency and respondent superior.

Count One: Professional Negligence

43.

Plaintiffs repeat, reallege, and re-aver each and every allegation contained in the paragraphs above as if fully set forth herein.

44.

Plaintiffs assert claims of professional negligence against all Defendants.

45.

Plaintiffs assert claims of professional negligence, directly, against Dr. Salazar.

46.

On October 7, 2024, Dr. Salazar owed professional duties of care to Maya Getahun.

Dr. Salazar violated these duties, and her violations caused or contributed to the damages alleged herein.

48.

Pursuant to O.C.G.A. § 9-11-9.1, the affidavit of Ann M. Dietrich, MD, FAAP, FACEP is attached as Exhibit 1 and incorporated herein by reference.

49.

Dr. Dietrich is an expert witness who is competent and qualified to testify to the standard of care required of Dr. Salazar on October 7, 2024.

50.

In her Affidavit, Dr. Dietrich identifies at least one act or omission constituting gross professional negligence on the part of Dr. Salazar and provides the factual basis for this opinion.

51.

Dr. Salazar was grossly negligent in the course of providing medical treatment to Maya.

52.

Plaintiffs assert claims of professional negligence, vicariously, against

Defendants Piedmont Healthcare, Piedmont Eastside, and EMC, for the negligence
of Dr. Salazar.

On October 7, 2024, Roshayla Bracely, RN, owed professional duties of care to Maya Getahun.

54.

Ms. Bracely violated these duties, and her violations caused or contributed to the damages alleged herein.

55.

Pursuant to O.C.G.A. § 9-11-9.1, the affidavit of Leslie R. Boyd, RN, BSN, CEN, is attached as Exhibit 2 and incorporated herein by reference.

56.

Ms. Boyd is an expert witness who is competent and qualified to testify to the standard of care required of Maya's treating nurses, including Roshayla Bracely, RN, on October 7, 2024.

57.

In her Affidavit, Ms. Boyd identifies at least one act or omission constituting gross professional negligence on the part of Maya's treating nurses, including Roshayla Bracely, RN, and provides the factual basis for her opinion.

58.

Ms. Bracely was grossly negligent in the course of providing medical treatment to Maya.

Plaintiffs assert claims of professional negligence, vicariously, against

Defendants Piedmont Healthcare, Piedmont Eastside, and EMC, for the negligence
of Roshayla Bracely, RN.

60.

Plaintiffs assert claims of professional negligence, vicariously, against

Defendants Piedmont Healthcare, Piedmont Eastside, and EMC, for the negligence
of the nurses and healthcare providers who treated Maya on October 7, 2024.

Count Two: Ordinary Negligence

61.

Plaintiffs repeat, reallege, and re-aver each and every allegation contained in the paragraphs above as if fully set forth herein.

62.

Plaintiffs assert claims of ordinary negligence against each of the corporate Defendants, Piedmont Healthcare, Piedmont Eastside, and EMC.

63.

Piedmont Healthcare owed its patients a duty of ordinary care to develop appropriate systems to protect patient safety, specifically policies and procedures to ensure a culture of safety, and to educate, monitor, and enforce those policies and procedures.

Piedmont Healthcare owed its patients a duty of ordinary care to stock the Hospital with appropriate equipment, particularly for a pediatric intubation.

65.

Piedmont Healthcare violated their duties of ordinary care, and their violations caused or contributed to the damages alleged herein.

66.

Piedmont Healthcare owed its patients a duty to ensure the medical providers practicing at their facility were properly credentialed.

67.

Upon information and belief, Piedmont Healthcare failed to properly credential, manage, and/or educate Dr. Salazar, Ms. Bracely, and the nurses and healthcare providers who treated Maya, thus breaching its duties.

68.

Piedmont Eastside owed its patients a duty of ordinary care to properly develop appropriate systems to protect patient safety, specifically policies and procedures to ensure a culture of safety, and to educate, monitor, and enforce those policies and procedures.

69.

Piedmont Eastside owed its patients a duty of ordinary care to stock the Hospital with appropriate equipment, particularly for a pediatric intubation.

Piedmont Eastside violated their duties of ordinary care, and their violations caused or contributed to the damages alleged herein.

71.

Piedmont Eastside owed their patients a duty to ensure the medical providers practicing at their facility were properly credentialed.

72.

Upon information and belief, Piedmont Eastside failed to properly credential, manage, and/or educate Dr. Salazar, Ms. Bracely, and the nurses and healthcare providers who treated Maya, thus breaching its duties.

73.

EMC owed its patients a duty of ordinary care to properly develop appropriate systems to protect patient safety, specifically policies and procedures to ensure a culture of safety, and to educate, monitor, and enforce those policies and procedures.

74.

EMC owed its patients a duty of ordinary care to stock the Hospital with appropriate equipment, particularly for a pediatric intubation.

75.

EMC violated their duties of ordinary care, and their violations caused or contributed to the damages alleged herein.

EMC owed their patients a duty to ensure the medical providers practicing at their facility were properly credentialed.

77.

Upon information and belief, EMC failed to properly credential, manage, and/or educate Dr. Salazar, Ms. Bracely, and the nurses and healthcare providers who treated Maya, thus breaching its duties.

Causation

78.

Plaintiffs repeat, reallege, and re-aver each and every allegation contained in the paragraphs above as if fully set forth herein.

79.

Each act of negligence by each Defendant caused or contributed to the damages alleged herein.

Wrongful Death and Estate Claims

80.

Plaintiffs repeat, reallege, and re-aver each and every allegation contained in the paragraphs above as if fully set forth herein. Plaintiffs assert a wrongful death claim pursuant to O.C.G.A. § 51-4-1 et seq., to recover the full value of the life of their child.

82.

Plaintiff Bethelhem Getu Hundie, as the personal representative of the Estate of Maya Getahun, asserts a claim to recover damages for the conscious pain and suffering experienced by Maya as a result of Defendants' negligence.

83.

Plaintiff Hundie also asserts a claim to recover for all medical and funeral expenses, and any and all related expenses.

84.

Plaintiffs are entitled to recover from Defendants reasonable compensatory damages to be determined by a fair and impartial jury.

Punitive Damages

85.

Plaintiffs repeat, reallege, and re-aver each and every allegation contained in the paragraphs above as if fully set forth herein.

86.

Plaintiffs show that Defendants' actions showed willful misconduct, malice, fraud, wantonness, oppression, or that entire want of care which would raise the

presumption of conscious indifference to consequences, entitling Plaintiffs to an award of punitive damages in an amount to be determined by a fair and impartial jury at trial.

Expenses of Litigation Damages

87.

Plaintiffs repeat, reallege, and re-aver each and every allegation contained in the paragraphs above as if fully set forth herein.

88.

Plaintiffs show that Defendants have acted in bad faith, have been stubbornly litigious, and/or have caused Plaintiffs unnecessary trouble and expense, thereby entitling Plaintiffs to recover expenses of litigation, including reasonable attorney's fees, pursuant to O.C.G.A. § 13-6-11.

Prayer for Relief

WHEREFORE, Plaintiffs pray for the following relief:

- a. that Defendants appear and answer this Complaint;
- b. that Plaintiffs have a trial by jury;
- c. that judgment be entered in Plaintiffs' favor in an amount in excess of \$10,000.00;

- d. that Plaintiffs recover compensatory damages to be determined by a fair and impartial jury;
- e. that Plaintiffs recover expenses of litigation, including reasonable attorneys fees, pursuant to OCGA 13-6-11;
- f. that Plaintiffs recover punitive damages;
- g. that all costs be taxed against some or all Defendants; and
- h. such other and further relief as the Court deems just and proper.

AFFIDAVIT OF ANN M. DIETRICH, MD, FAAP, FACEP, REGARDING MAYA GETAHUN

PERSONALLY APPEARS before the undersigned authority duly authorized to administer oaths Ann M. Dietrich, MD, FAAP, FACEP, who after first being duly sworn states as follows.

Introduction

- 1. This affidavit addresses medical negligence that occurred on October 7, 2024, when 2-year-old Maya Getahun received care at Piedmont Eastside Medical Center ("Piedmont" or "Hospital").
- 2. I use the term "standard of care" to refer to that degree of care and skill ordinarily exercised by members of the medical profession generally under the same or similar circumstances and like surrounding conditions as pertained to the providers I discuss here.
- 3. I hold all the opinions expressed below to a reasonable degree of medical probability—that is, more likely than not.
- 4. I understand the purpose of this affidavit is to satisfy the requirements of O.C.G.A. § 9-11-9.1 which requires the plaintiff "to file with the complaint an affidavit of an expert competent to testify, which affidavit shall set forth specifically at least one negligent act or omission claimed to exist and the factual basis for each such claim." This affidavit does not purport to express every opinion I hold regarding negligence but rather to satisfy the requirements of Georgia law.

Qualifications

- 5. I am more than 18 years of age, suffer from no legal disabilities, and give this affidavit based upon my own personal knowledge and belief.
- 6. I do not recite all my qualifications here. I recite them only to the extent necessary to establish my qualifications for purposes of expert testimony under OCGA § 24-7-702. My curriculum vitae, which is attached as Exhibit A,

provides further detail about my qualifications. I incorporate and rely on that additional information here.

- 7. I am qualified to provide expert testimony pursuant to O.C.G.A. § 24-7-702.
 - a. In 2024, I was licensed by an appropriate regulatory agency to practice my profession in the state in which I was practicing or teaching in the profession. Specifically, I was licensed by the state of South Carolina to practice as a physician. That's where I was practicing in 2024.
 - b. In 2024, I had actual professional knowledge and experience in the area of practice or specialty which my opinions relate to—specifically, the tasks identified below on which I offer standard-of-care opinions.
 - I had this knowledge and experience from being regularly engaged in the active practice of the foregoing areas of specialty of my profession for at least three of the five years prior to October 7, 2024, with sufficient frequency to establish an appropriate level of knowledge of the matters my opinions address. Specifically, I am a pediatric emergency medicine physician, and for many years I have had great familiarity with each of the tasks on which I offer standard-of-care opinions below.

Evidence Considered

8. In forming the opinion expressed in this affidavit, I have reviewed the following records pertaining to Maya Getahun: the Piedmeont Eastside Medical Center medical records and the Death Certificate.

Failure to Timely Administer Epinepherine

- 9. Requirements: Under the circumstances ascertainable from the records identified above, the standard of care requires an ED physician to immediately inject IM epinephrine. Specifically, the standard of care requires an ED physician to recognize that the patient is experiencing anaphalactic and is at risk of losing her airway.
- 10. Violations: On October 7, 2024, Dr. Richisa Salazar violated the standard of care by causing a critical delay in the administration of IM epinephrine which

- caused, or contributed to, Maya Getahun's death. This violation was a gross departure from the standard of care.
- 11. The factual basis for this allegation, as determined by the record review, is the following:
 - a. On October 7, 2024 at approximately 19:16 hrs, Maya Getahun was triaged at Piedmont Eastside, South Campus.
 - b. The nursing assessment showed the Patient had been bitten by ants about 30 minutes prior to arrival and was "fussy" with labored breathing with wheezing noted. Patient was well oxygenated with SpO2 at 94% Room air.
 - c. Patient was clearly experiencing an anaphylactic reaction.
 - d. Dr. Salazar was the attending physician.
 - e. Dr. Salazar waited for approximately 24 minutes from the time of Patient's arrival to administer the IM epinepherine, a critical delay under the circumstances.
- 12. Again, this affidavit is given for the limited purpose of satisfying the Georgia procedural requirements under the law, and is not a reflection of all my opinions regarding this matter.

AFFIDAVIT OF LESLIE BOYD, RN, BSN, CEN REGARDING MAYA GETAHUN

PERSONALLY APPEARS before the undersigned authority duly authorized to administer oaths, LESLIE BOYD RN, BSN, CEN, who after first being duly sworn states as follows.

Introduction

- This affidavit addresses medical negligence that occurred on October 7, 2024, when 2-year-old Maya Getahun received care at Piedmont Eastside Medical Center South Campus ("Piedmont" or "Hospital").
- I use the term "standard of care" to refer to that degree of care and skill
 ordinarily exercised by members of the nursing profession generally under the
 same or similar circumstances and like surrounding conditions as pertained to
 the providers I discuss here.
- I hold all the opinions expressed below to a reasonable degree of medical probability—that is, more likely than not.
- 4. I understand the purpose of this affidavit is to satisfy the requirements of O.C.G.A. § 9-11-9.1 which requires the plaintiff "to file with the complaint an affidavit of an expert competent to testify, which affidavit shall set forth specifically at least one negligent act or omission claimed to exist and the factual basis for each such claim." This affidavit does not purport to express every opinion I hold regarding negligence but rather to satisfy the requirements of Georgia law.

Qualifications

- I am more than 18 years of age, suffer from no legal disabilities, and give this affidavit based upon my own personal knowledge and belief.
- I do not recite all my qualifications here. I recite them only to the extent
 necessary to establish my qualifications for purposes of expert testimony under
 OCGA § 24-7-702. My curriculum vitae, which is attached as Exhibit A,

provides further detail about my qualifications. I incorporate and rely on that additional information here.

- 7. I am qualified to provide expert testimony pursuant to O.C.G.A. § 24-7-702.
 - a. In 2024, I was licensed by an appropriate regulatory agency to practice my profession in the state in which I was practicing or teaching in the profession. Specifically, I was licensed by the state of Georgia to practice as a registered nurse. I also have a compact license which allows me to practice in over 30 states.
 - b. In 2024, I had actual professional knowledge and experience in the area of practice or specialty which my opinions relate to—specifically, the tasks identified below on which I offer standard-of-care opinions.
 - I had this knowledge and experience from being regularly engaged in the active practice of the foregoing areas of specialty of my profession for at least three of the five years prior to October 7, 2024, with sufficient frequency to establish an appropriate level of knowledge of the matters my opinions address. Specifically, I am an emergency department nurse, and for many years I have had great familiarity with each of the tasks on which I offer standard-of-care opinions below.

Evidence Considered

8. In forming the opinion expressed in this affidavit, I have reviewed the medical records for Maya Getahun from Piedmont Eastside Medical Center South Campus. As more records become available, I will review as requested and reserve the right to modify or add to my opinions based on new or additional evidence.

Failure to Timely Administer Epinepherine

9. Requirements: Under the facts and circumstances ascertainable from the medical records, the standard of care requires hospital nurses to promptly administer epinephrine. Specifically, the nurses are required to recognize that the patient is experiencing anaphalaxis and needs immediate medications.

- 10. Violations: On October 7, 2024, nurses at Piedmont Eastside Medical Center South, including Roshayla Bracely, RN, violated the standard of care by waiting an unreasonable amount of time before administering IM epinephrine which caused, or contributed to, Maya Getahun's death. This violation was a gross departure from the standard of care.
- 11. The factual basis for this allegation based on the medical records, is the following:
 - a. On October 7, 2024, at approximately 19:16 hrs, Maya Getahun was triaged at Piedmont Eastside, South Campus.
 - b. The nursing assessment showed the Patient had been bitten by ants about 30 minutes prior to arrival and was "fussy" with labored breathing with wheezing noted. Patient was well oxygenated with SpO2 at 94% Room air.
 - c. Patient was clearly experiencing an anaphylactic reaction.
 - d. Piedmont nurses, including Roshayla Bracely, RN, waited over 20 minutes from the time of Patient's arrival to administer the IM epinepherine, a critical delay under the circumstances.
- 12. Again, this affidavit is given for the limited purpose of satisfying the Georgia procedural requirements under the law, and is not an expression of all my opinions regarding this matter.
